### ALL APPLICATIONS MUST BE FILLED IN COMPLETELY AND CLEARLY

**\*\*Email correspondence\*\* IN SUBJECT LINE- Please type show name and your last name.**

You must provide: 4 Photos, three photos, or more, of items that are sold in your booth, and one photo of your entire booth set up. Email photos with your email application. Photos must be of quality to use for later advertising. Please send pics of your newest, current, merchandise.

NO 'copy paper' copies of photos will be accepted. Original Photos will be accepted through mail in application. Emailed pictures are preferred.

All categories must be accurately accounted for and juried in. Please describe in return email or written on the back of this application all categories of items you will be selling in your booth. Once juried in, Categories cannot be added without prior approval from Keepsake Collection. All items are subject to review the day of show. Keepsake Collection reserves the right to make final determination of all conditions. Any unsuitable items will be removed immediately upon request of management. Profanity in print, especially the "F" word, items are not to be displayed in a prominent spot. At our discretion you may be asked to remove items.

All tables shall be covered neatly to the floor on all sides. All backdrops, divider behind and between booths must be astatically attractive. Exhibit spaces are filled in order that applications are received with full payment.

Payments will be processed immediately upon confirmation into show. When each category is full, we close that category. Returned check fee of \$30.00 will be applied.

**A self-addressed stamped envelope must accompany all mail in applications.**

### NO Refunds once accepted into a show.

Keepsake Collection, any helpers, any facility event is held at will assume no responsibility for any injury or loss or legal action for any reason to the undersigned, their helpers, or their property. The undersigned agrees to indemnity and hold harmless all above for any and all set claims.
